

Vírtual General Meetíng -Sunday March 21 @ 1:00pm

A virtual Annual General Meeting of members will be held **Sunday, March 21, 2021 at 1:00 p.m.** The meeting will be **entirely virtual** in order to comply with COVID-19 pandemic regulations. Details about how to connect to the virtual annual general meeting will be sent by mailchimp Friday, March 19, 2021.

The business to be transacted at the meeting will include **presentations and approval of:**

- Committee Reports;
- Financial Statements;
- 2021 Executive;
- Amended Constitution; and
- Amended Reciprocal Policy.

All members are welcome and encouraged to attend. Only regular members who are in good standing are entitled to attend and vote at the general meeting.

Proposed Constitutional Amendment

The current constitutional wording is as follows:

Board of Directors Operations

Section 2

- 2.1 Flag Officers of the Club shall be:
 - Commodore
 - Vice Commodore
 - Secretary
 - Treasurer

Directors and Flag Officers shall be comprised of not more than 12 members in total. The Flag Officers and Directors shall be known as Members of the Board of Directors, hereinafter called Members of the Board.

We are proposing that we change 12 to 16. There are two key reasons for the change. They are:

- This year, we were unable to appoint a Communications Director as in previous years because we had already had 12 Directors with a full slate and a Past Commodore;
- By increasing the number, we would have the flexibility to have more people on the Board to reduce volunteer workload or work on a special project; and
- This allows $4\5$ flag officers and $11\12$ Directors.

Therefore, we are recommending that we amend the Constitution to allow the Board to be comprised of not more than 16 members in total.

Proposed Reciprocal Policy Change for Approval at AGM

Last year we changed our reciprocal policy. We believe the wording was well intentioned but it has some flaws, which may not have been fully realized. The current wording states "FPYC provides the first night free mooring and reciprocal privileges to current members of all yacht clubs on Lake Ontario.";

While the intent was to reduce the overall cost of reciprocals, the current wording is prohibitive. For example, 'clubs on Lake Ontario' precludes those in Burlington Bay, The St. Lawrence River, Bay of Quinte, Sodus Bay, Collins Bay and many more.

We have not paid a reciprocal to any club that we have not visited. Plus, we have had many longstanding reciprocal agreements with clubs for years as a matter of courtesy without having them visit. We are not sure we want to advise a club we are no longer accepting them as a reciprocal. It only raises questions from others where we have a reciprocal agreement.

It has taken FPYC years to build a good reputation with other yacht clubs. We believe that cruising and reciprocals has a high importance for many members. We did put in other restrictions, which are to remain:

- o Limiting the number of boats on reciprocal cruises;
- o Reciprocals may not be used the day before or the day after Club Cruises; and
- o We only offer three one-night reciprocal visits per season.

Therefore, it is being proposed that we remove the words Lake Ontario from our policy. We could further reduce costs by eliminating Harbour City Y C from our reciprocal list. HCYC has 4 small slips in the rear of Toronto Island Marina and they appear to be more dilapidated each year. HCYC is mostly members from Outer Harbour Marina, where we do not get a reciprocal at the marina and we get about 10 HCYC reciprocals annually.

From the Membership Committee

Many thanks to all who paid the interim membership fee in 2020! Your generous contribution funded FPYC fixed costs such as insurance, association dues, related fees and website management.

With the ongoing challenges related to the COVID-19 pandemic, the Board of Directors is currently deliberating the membership fee for the 2021 season. The status of the Fifty Point Marina Reciprocal Policy as well as opportunities to host social events are significant considerations when setting the fee. We will have further information available at the March 21st AGM meeting.

"Pot's" and Pans

There's nothing like doing a little bit of baking when it's cold and grey outside.

This loaf is moist and very flavorful.

It will fill the kitchen with a wonderful aroma as it bakes! Enjoy.

Carrot bread with Cream Cheese Glaze

Ingredients

Carrot Bread

2¼ cups flour

1 tsp ground cinnamon

1 tsp baking soda

1 tsp baking powder

½ tsp kosher salt

¾ cup vegetable oil

34 cup sugar

½ cup brown sugar

½ cup buttermilk

2 eggs

1 tsp vanilla extract

2 cups coarsely grated carrots

Cream Cheese Glaze

4oz cream cheese, room temperature

½ cup icing sugar

2 tbsp milk

½ tsp vanilla extract



Directions

Preheat oven to 325°F. Line a 9x5-inch loaf pan with parchment paper, draping it over the edges to cover the sides. Lightly coat with non-stick cooking spray. In a medium bowl, combine flour, cinnamon, baking soda, baking powder and salt. Set aside. In a large bowl, whisk together vegetable oil, sugar, brown sugar, buttermilk, eggs and vanilla extract. Gently stir in grated carrots and flour mixture, just until blended. Pour into prepared loaf pan and bake 65-70 minutes. Let cool for 10 minutes before removing from pan.

For the glaze, using an electric mixer, cream together cream cheese, icing sugar, milk and vanilla extract until smooth. Drizzle over cooled carrot bread. (Recipe courtesy of BITE ME MORE INC)
