





### Do You Fly Your Burgee?


When you are travelling, do you fly your FPYC burgee? Some yacht clubs are starting to request that members must show a current yacht club membership card and fly their yacht club burgee.

# HöllisWealth...

#### Generating Higher Income

Since 2000 we have witnessed a decline in GIC returns resulting in a decline of returns from GICs of over 60%, from around 5%, to today's average of about 2%. Inflation during this time has averaged about 2.2% annually meaning that the investment may have lost some buying power since the returns were further eroded by income taxes.

Individuals committed to GICs generally have a fear of losing their principal. This is somewhat understandable after the financial turmoil of 2008/09; however a continued decline in purchasing power, out of a misguided belief in safety of capital, is devastating on one's long term financial future. Unless inflation is dead and will remain so for the rest of their lives, they are deluding themselves with this sense of security. So what are the options?

In the past we discussed Income Funds. Recently some members have asked us about generating higher income, so we feel this is good time to address income funds again. We will use the history of one very good performing fund, the Sentry Growth and Income Fund, to drive home this point. The risk rating for this fund is classified as low to medium risk.

Had you invested \$250,000 in this fund at its inception on August 8, 2008 (Just weeks prior to the start of the financial crisis) you would have established a monthly income of \$1,722.27, which has been paid consistently since then until June 30, 2014, totalling \$118,219, however of this total only \$47,020 would have been included in income; comprised of \$4,080 in dividends, \$15,141 in interest and foreign income and \$55,597 in capital gains (of which only 50% is included in income for tax purposes). In due course the taxman will get his share when the investment is disposed of as there will be capital gains, but as only 50% of capital gains is subject to tax, this make it an even more attractive investment. As at June 30, 2014 the investment was worth \$275,850! During this time the fund experienced declines, and at its lowest point the market value fell to below \$200,000. Investors who ignored the decline have since been rewarded for their patience.

How did the GIC investor fare over this time? Earning 2.5%, the investor would have received a total of \$36,979 during the same period, with all the income subject to tax in a non-registered account. Yes, on paper the GIC was never worth less than the \$250,000; however it also had no opportunity to appreciate. Comparing the income numbers provided above we see that the investor in the Sentry Growth and Income Fund has generated \$81,240 more in income and as at June 30 and had a capital gain of \$25,850. Equally important is that with the Sentry Fund, they paid less tax.

Our question? Should the guarantee of the GIC principal be really important in a portfolio with a long term view?



### September Race Report By Garry Cooke



# Wind, Weather and Waves

### **Warm Front or Low Pressure Approaching**

### Weather – Sky and Clouds

Early on the weather will be fair with patches or thin layers of mid-and/or high cloud (Ac-altocumulous and / or Ci-cirrus/Cs-cirrostratus), but the clouds will steadily increase becoming overcast. With the warm front, a period of rain or thunder showers then misty conditions with low clouds near the front. If a low is passing near or to the south of you, steady light rain with mist and low clouds may occur.

Later on with a strong low passing near or to your south, the layers will thicken to As-altostratus, then it will rain. With a weak low, a low passing well to your north, or a weak warm front, you will see broken layers of Ac thickening to overcast, then showers. Embedded thunder showers during late spring and summer may occur. As the warm front/low nears, higher cloud layers are often replaced by low clouds (Sc-stratocumulus and St-stratus) and mist in or near the rain, followed by fog and drizzle until the front passes and wind shifts.

#### Weather – Wind

Early on the winds will be light from northeast to southeast, becoming light to moderate from the east quadrant as clouds thicken.

Later as the low is passing to your south, winds will back (change direction counter clockwise) and moderate. If a low is passing to your north, winds will veer (change direction clockwise) gradually changing to the southeast or south then southwest after the warm front passes.

#### Weather – Pressure

Pressure will fall until the front passes then will steady or rise slightly. If low is passing to your south, the pressure will fall until the winds back to the north then will steady or will rise slowly.



Cirrus Clouds - Thin and wispy



Cirrostratus - Milky, translucent cloud veil of ice crystals, which sometimes causes halo appearances around moon and sun.

Altostratus Clouds - Dense, gray layer cloud, often evenly and opaquely, which lets the sun shine through only a little



Stratocumulus Clouds - Low, lumpy layer of clouds
